Requirements to participate in the call:

Research Project Title: HARMONY PLUS: HEALTHCARE ALLIANCE FOR RESOURCEFUL MEDICINES OFFENSIVE AGAINST NEOPLASMS IN HEMATOLOGY – PLUS.

Haematological malignancies (HM), also known as blood cancers, are a heterogeneous and complex group of multicausal diseases that can't be easily diagnosed nor treated. Nowadays most treatments are extremely complex, and advances in patient diagnosis and therapies slow due to the low number of patients per centre. Thus, there is a need to harmonise, store, and analyse the current HM information to speed-up and support the decision-making process for patients' access to new therapies.

HARMONY is a European Network of Excellence that captures, integrates, analyzes and harmonizes Big Data from high quality multidisciplinary sources for the purpose of acquiring valuable knowledge across the spectrum of hematologic malignancies (HMs). The HM-specific Big Data platform developed by HARMONY will enable the rapid definition of promising treatment strategies, and prediction of adverse events likely to be associated with such strategies.

HARMONY PLUS takes advantage of the capabilities of the HARMONY Big Data platform to incorporate myeloproliferative neoplasms, including chronic myeloid leukemia, polycythaemia vera, essential thrombocythaemia, and myelofibrosis; and lymphoproliferative disorders, including Hodgkin's lymphoma, Waldenström macroglobulinemia and all the other rare HMs not covered by HARMONY Project.
